	Emails had been received from two residents of Rectory Farm Barns, objecting to the planning application for Land to the West of Werneth. The emails were read to the meeting; their main concern was the likely congestion of, and poor visibility along, the privately owned access road between Heney Road and Damerons Farm. A resident neighbouring on the property noted that landowners do need to diversify, but that greater use of the roadway would result in higher costs for those who share the upkeep of the road.
